Eliminating Veteran Homelessness

- **President Obama and Secretary Shinseki were committed to eliminating homelessness for our nation's Veterans.**
- **Eliminating Veteran homelessness is a very high national priority.**
- **VA developed a comprehensive plan to achieve this goal.**
- **HUD-VASH is a prominent element in that plan**





Program Design

- **The HUD-VASH program was developed to provide case management and supportive services paired with a “Housing Choice” Section 8 voucher to eligible homeless Veterans**
- **HUD-VASH case managers work to maintain Veterans recovery and independence**
- **HUD-VASH has the opportunity to provide housing to homeless Veterans**





PHA Side of HUD-VASH

- Coordinate with Veteran Affairs to receive referrals
- Provide orientation to the HUD-VASH program
- Work with a case manager to successfully house veterans within 150 days





Eligibility

- **VA determines clinical eligibility**
- **PHA determines:**
 - * **Meet income requirements**
 - * **Not on lifetime sexual offense registry requirement**

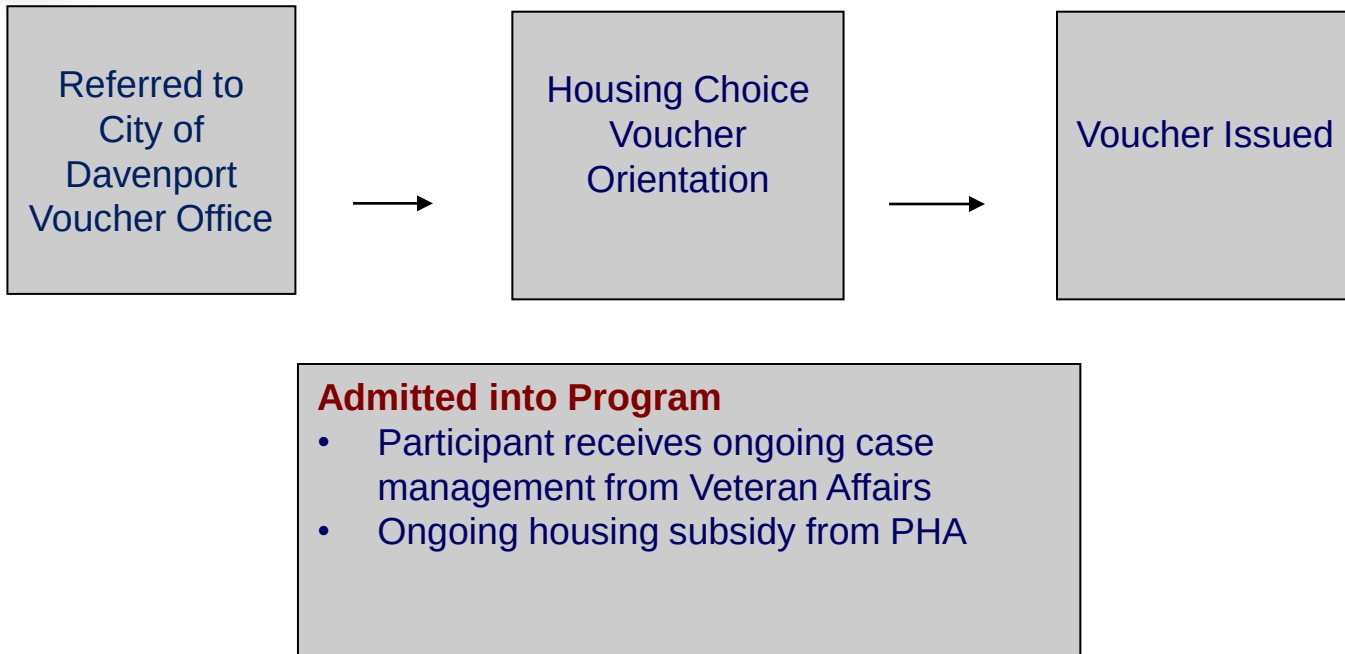
